2017 SCHOLARSHIP APPLICATION

The Rotary Club of Marblehead Harbor will award three (3) scholarships for 2017. The club will choose one (1) candidate for The Frattie Welch Scholarship-- a four (4) year scholarship of \$2500 per year (\$10,000 for 4 years). Two (2) other candidates will each be awarded a \$3000 single year grant that is not renewable.

- c. Submit seven copies (1 original, 6 copies).
- d. INCOMPLETE APPLICATIONS OR APPLICATIONS RECEIVED AFTER THE DEADLINE WILL NOT BE CONSIDERED.

2. SUBMISSION DEADLINE: The application must be received by Monday, April 3, 2017, 4 p.m.

- a. any graduating senior of Marblehead High School; or
- b. a graduating senior, who is a resident of Marblehead, but attends an out-of-town high school;
- c. a graduate who intends to pursue a degree from an accredited college, university or vocational school beginning the following semester
- d. Children and grand-children of Rotarians are not eligible to apply.

5. The ideal candidate is an individual:

- a. who has a strong academic record;
- b. has demonstrated leadership, determination and integrity; and
- c. who can best represent the values of Rotary--building goodwill and friendship, high ethical standards, concern about the needs of society, and the ideal of Service above Self.

6. The Rotary Club of Marblehead Harbor scholarship program does not discriminate by race, color, creed, gender, sexual preference, disability or national origin.

7. Financial need will be considered.
